Prerequisites: Course participation is limited to entry-level DPT students in their second year of the UF DPT program who have successfully completed all prior courses

Purpose and Outcome

Course Overview: This course is a full-time clinical experience in which the student is supervised by a licensed physical therapist. It is designed to provide students the opportunity to work in a real practice environment under the supervision of a physical therapist who will serve as a clinical instructor (CI). Some students may have more than one clinical instructor or there may be more than one student assigned to a single CI. All are proven models of clinical instruction. This is the first of four full-time 8-week clinical experiences. Students are matched to appropriate clinical settings including, but not limited to acute care, outpatient physical therapy, inpatient rehab, or specialty settings. Clinical sites will provide adequate opportunities for students to practice entry-level skills based on practice criteria included in the Clinical Performance Instrument - CPI. The culmination of all four clinical experiences will allow the student to demonstrate competence in professional behaviors and management of patients with a variety of movement system dysfunction. These clinical experiences will also expose the student to a variety of age groups, disease types and disability levels that are found in patient care.

Relation to Program Outcomes

The following outcomes have been established for graduates of the UF DPT program:

Students/graduates (SG)1: To prepare entry-level students/graduates to become practitioners of collaborative, interdisciplinary, evidence-based practice and meet the dynamic needs of physical therapy healthcare consumers.

Expected Outcomes

- SG1a. The Program will enroll entry-level students/graduates who meet high standards in the areas of academic aptitude.
- SG1b. Students/graduates will be independent problem-solvers and critical thinkers.
- SG1c. Students/graduates will be autonomous practitioners able to diagnose and treat movement disorders.
- SG1d. Students/graduates will be physical therapists who address the unique physical and psychosocial characteristics of each individual client.
- SG1e. Student/graduates will be physical therapists who adhere to state and professional ethical and legal regulations.
- SG1f. Student/graduates will be physical therapists who provide safe and effective physical therapy services in a variety of clinical settings.

SG2: To prepare entry-level students/graduates to serve as active participants and leaders in the profession and community.

Expected Outcomes

- SG2a. The Program will enroll a diverse student body in terms of life experience who have demonstrated a commitment to service and have a high leadership potential.
- SG2b. Students/graduates will value active involvement in community and professional service organizations.
- SG2c. Students/graduates will hold leadership positions in professional and community service.

Course Objectives and/or Goals:

1. Demonstrate professional responsibility by timely and accurate completion of all regulatory, facility and program tasks and assignments.
2. Demonstrate professional behavior in all interactions with stakeholders not limited to patients, co-workers, clinical instructors, and faculty.
3. Deliver an in-service presentation or develop a project on a topic mutually agreed upon by the student and the clinical instructor
3. Achieve “**Advanced Beginner**” or above on all criteria in the CPI.

Advanced Beginner Level Defined as:

- A student who requires clinical supervision 75% – 90% of the time managing patients with simple conditions, and 100% of the time managing patients with complex conditions.

- At this level, the student demonstrates consistency in developing proficiency with simple tasks (eg, professional behavior, medical record review, goniometry, muscle testing, and simple interventions as outlined in the Clinical Performance Instrument - CPI), but is unable to perform skilled examinations, interventions, and clinical reasoning skills.
- The student may begin to share a caseload with the clinical instructor.

Instructional Methods

Students receive clinical mentoring on-site by a licensed physical therapist(s) at their assigned clinical location. Students may be placed in a 1:1 (student to instructor) or a collaborative learning environment (more than one student to one instructor) or one student to more than one clinical instructor. In each of these instructional environments, students are expected to demonstrate adult learning behaviors by seeking out learning opportunities and professionally communicating goals, expectations, questions and concerns to clinical mentors and faculty to optimize their individual learning opportunity.

What is expected of you?

For your coursework, you are expected to actively engage in checking your UF email and the online course submitting all assignments throughout the semester in a timely fashion. Additionally, you must arrive to your clinical facility fully prepared by completing all assigned tasks and having developed an understanding of the patients you may see that day. This preparation gives you the knowledge or practice needed to engage in higher levels of learning and to meet the needs of your patients. If you are not prepared, you may struggle to keep pace with the activities and patient needs occurring that day and it is unlikely that you will reach the higher learning goals of the course. As stated, you are expected to actively participate in your learning and professional development. Your participation fosters a rich experience for you, your peers, your clinical instructor, and your patients that facilitates overall mastery of the course objectives.

Grading

Standardized criteria according to the Student Clinical Performance Instrument of the APTA will be utilized by clinical instructors to assess student performance. This course is graded as Satisfactory or Unsatisfactory based on the student's ability to meet the course objectives noted above. Students must complete online assignments accurately in a timely fashion. **Students must achieve a minimum of 80% of the points for the online assignments and meet the "Advanced Beginner" criteria in the Student Clinical Performance Instrument to achieve a "Satisfactory" grade.**
